Project Director's Report December 19, 2020

- The COVID-19 Pandemic and the corresponding shutdown of various organizations within the territory has severely hampered our ability to carry out many of our anticipated tasks.
- I engaged the Commissioner of Property and Procurement and the HFR lease process, which was dormant, has been revived. The lease is being revised for signature and execution.
- The FY 20 Year 5 Subaward Agreement was finally received on December 13th and executed on December 15th. This was 7 months after it was expected.
- The No Cost Extension for FY 20 Year 4 Subaward was finally approved on December 1, 2020, even though we submitted the request on May 22, 2020.
- OCOVI's EOI Proposal for FY22-26 was approved in November.
- We commenced using the ROV to assess the Redhook dock.

Project Director's Report December 19, 2020

- The COVID-19 Pandemic and the corresponding shutdown of various organizations within the territory has severely hampered our ability to carry out many of our anticipated tasks.

- Commenced discussion with World Ocean School Roseway to initiate outreach activities on St. Croix
- Tropical Shipping deployed two of eight Drifter Buoys that we received.
- We secured permission for JOA to install tide gauges at Magens Bay and Johns Folly Bay. JOA is in the territory and have installed the devices. Kenique Liburd has been working with them.

- Roy and I attended a Fish and Wildlife meeting and engaged an individual from Limetree
 Bay Terminal who is interested in us deploying a current monitoring device, like whatexist
 at Crown Bay.
- Antonio Farchette was paid out the balance of his Vembu Subramanian Award, based on work he did towards his thesis work. The other two students probably will not receive their Vembu awards because their project involved attending conferences that were cancelled because of COVID-19.
- We had robust new Social Media promotion of OCOVI's Education & Outreach with the addition of Madyson Miller.
- Steve Henry was contacted by Yasmin Detres of UPR to begin discussion on developing the USVI's Spatial temporal evolution of coastal areas. The tool containing Puerto Rico's data was shared with us.
- Executed the Chief Science Officer contract after the NCE was approved.
- We contracted Rebecca Hoffart to assist various OCOVI activities, including development Lesson Plans, supervise the ROV's, and assist the Project Director.
- We paid the annual Liability Insurance Premium from Tunick.
